



2017 COURT SCHEDULE OCONEE JUDICIAL CIRCUIT

1. UNLESS OTHERWISE ORDERED BY THE PRESIDING JUDGE, ALL CIVIL COURT WILL BEGIN AT 9:00 A.M. AND ALL CRIMINAL COURT WILL BEGIN AT 9:30 A.M. However, with respect to trial terms and jury trials, each Judge will direct court officers, counsel and jurors when to report.
2. Special terms will be assigned as necessary. Cases with unusual time requirements should be discussed separately with one of the Judges.
3. Clerks shall prepare calendars to include all pending cases for each civil and criminal calendar call and shall mail a copy to the Judges, all counsel of record and all parties not represented by counsel at least two weeks prior to the scheduled calendar call. Clerks shall maintain a copy of each calendar and a copy of the names and addresses of those persons to whom it was mailed. A final copy of each calendar should be provided to the presiding Judge at least 24 hours in advance of Court. Any cases requesting to be added to the calendar after this time must be done so with permission from the presiding Judge.
4. Clerks and sheriffs shall notify all attorneys, parties, prosecutors and any other persons deemed necessary for the possible settlement of cases to be present for all calls of the criminal calendars.
5. The assignment of a particular court date to a particular Judge on this schedule is done purely for the convenience of the Judges and may be changed by the Judges at any time without notice.
6. Counsel in cases where one Judge is disqualified should make certain that the qualified Judge is to hold court on a particular date before seeking a hearing on that date.
7. Revocation days will be scheduled as needed by the Judges . Revocation cases MUST be filed three (3) days prior to the scheduled court day.
8. Bench Trial dates have been scheduled with no county listed. The county in which these court dates will be held will be scheduled by the Judges as they see fit. These dates are scheduled so that the Judges can hold criminal and civil bench trials as the need arises.
9. The Judges prefer that any order setting a hearing (e.g., a temporary hearing in a divorce case) be presented for signature to the Judge before whom the hearing is to be held. If this cannot be done and another Judge signs such order, the Judge before whom the hearing shall be held shall be immediately notified by counsel of the entry of such order. Clerks may sign nisi and show-cause orders and schedule cases for hearings on motion days where no immediate relief is requested.
10. Personal appearances by counsel at civil calendar calls is not mandatory, but failure of counsel, or of parties not represented by counsel to appear or otherwise make announcements at calendar calls may result in dismissal of the case. Parties and counsel may make calendar call announcements to the clerk by letter or telephone, subject to the following: [a] The Court is not bound by any letter or telephone announcement or agreement of counsel regarding the continuance of a case; [b] Parties and counsel making announcements by letter do so at their own risk and are responsible for knowing what happened in their cases at calendar calls.
